


Panola College received a \$1,507,332 federal grant to assist with the impact of COVID-19

Panola College received a \$1,507,332 federal grant to provide direct emergency cash to students, and to cover school expenses related to the coronavirus and COVID-19. The funding is available through the Higher Education Emergency Relief Fund authorized by the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

Half of the funding received provided direct cash payments to students to help with housing, utilities, food, and other expenses they may have incurred during the coronavirus crisis. The application was available on the Panola College website from April 27 to May 22, 2020.

Panola College Foundation Established Emergency COVID-19 Student Relief Fund

Panola College Foundation established a \$30,000 financial relief package available to assist students who have been impacted by the COVID-19 crisis. Students who were enrolled in the spring 2020 semester or who are enrolling in the May, summer or fall 2020 terms were eligible to apply for assistance.

The fund provided one-time payments to students who need help with expenses to complete the spring semester or towards tuition and fees for May and summer terms. Awards ranged from \$100 to \$250, with a maximum award of \$500.

Expenses that were covered by the relief fund include tuition, books, and other essential academic expenses; transportation related to academic needs; food and hygiene items; utilities; medications and other costs related to medical care of safety needs.










Panola College Foundation Program Grants
