#### About Panola College

Panola College is a comprehensive public community college serving the citizens of Harrison, Marion, Panola, and Shelby counties. Founded in 1947, Panola College has a rich tradition of helping students achieve their academic and personal goals.

Enrollment at the College has grown from fewer than 100 students at the first registration in January of 1948 to 2,636 (including continuing education) in the fall of 2023. The enrollment not including continuing education was 2,385 students. The College provides many services that enrich the lives of individuals in the region by offering a wide range of educational and training opportunities to citizens of all ages. Students can choose from a variety of technical programs that provide quick employment and career enhancement opportunities, or they can pursue a two-year associate degree and academic courses for transfer to a four-year university.

Panola College offers courses through its main campus in Carthage and at centers in Marshall and Center, Texas. Panola College is also a leader in distance education. Eleven degrees and fifteen certificates are partially offered online, while five degrees and twelve certificates are offered online through the Canvas Learning Management System.

Panola College provides numerous cultural events to the local community. Patrons of the arts can choose from a wide selection of plays, concerts, lectures, and art exhibits presented annually at the College. For those who prefer athletic competition, Panola College is home to the Panola Ponies and Fillies intercollegiate basketball, volleyball, baseball and rodeo teams.

An associate degree from Panola College is equivalent to the first two years of a four-year degree but at a fraction of the cost charged by state and private universities. Graduates transfer to a wide range of four-year institutions that include Texas A&M University, the University of Texas at Tyler, East Texas Baptist University, Stephen F. Austin State University, Louisiana State University and many others.

Panola College offers an Associate of Arts/Science, an Associate of Teaching, an Associate of Science in Music, 18 Associate of Applied Science degrees, 30 Certificates, 8 Field of Study programs, and 19 Occupational Skills Awards. Workforce/Continuing Education offers 17 Institutional Credentials that Leads to a Licensure or Certification programs.

Each year from 2012 to 2023, Panola College was recognized as a "Great College to Work For" by The Chronicle of Higher Education. Panola College won honors in all 10 categories this year – a first for the College:



#### Administrative Organizational Chart











### Student Services Department Organizational Chart

#### Demographic Profile

The population in Harrison County, Texas was 69,098 per American Community Survey data for 2018-2022. The region has a civilian labor force of 32,926 with a participation rate of 60.4%. Of individuals 25 to 64 in Harrison County, Texas, 22.8% have a bachelor's degree or higher which compares with 35.8% in the nation.

The median household income in Harrison County, Texas is \$63,427 and the median house value is \$164,400.



#### **Employment Trends**


As of 2023Q4, total employment for Harrison County, Texas was 25,094 (based on a four-quarter moving average). Over the year ending 2023Q4, employment declined 1.2% in the region.



Employment data are derived from the Quarterly Census of Employment and Wages, provided by the Bureau of Labor Statistics and imputed where necessary. Data are updated through 2023Q3 with preliminary estimates updated to 2023Q4.

#### **Unemployment Rate**

The unemployment rate for Harrison County, Texas was 4.4% as of April 2024. The regional unemployment rate was higher than the national rate of 3.5%. One year earlier, in April 2023, the unemployment rate in Harrison County, Texas was 4.0%.



#### Wage Trends

The average worker in Harrison County, Texas earned annual wages of \$56,314 as of 2023Q4. Average annual wages per worker increased 2.4% in the region over the preceding four quarters. For comparison purposes, annual average wages were \$69,861 in the nation as of 2023Q4.

#### Cost of Living Index

The Cost of Living Index estimates the relative price levels for consumer goods and services. When applied to wages and salaries, the result is a measure of relative purchasing power. The cost of living is 5.0% lower in Harrison County, Texas than the U.S. average.



#### **Industry Snapshot**

The largest sector in Harrison County, Texas is Manufacturing, employing 6,029 workers. The next-largest sectors in the region are Educational Services (3,102 workers) and Retail Trade (2,199). High location quotients (LQs) indicate sectors in which a region has high concentrations of employment compared to the national average. The sectors with the largest LQs in the region are Mining, Quarrying, and Oil and Gas Extraction (LQ = 12.22), Manufacturing (2.99), and Utilities (2.40).

Sectors in Harrison County, Texas with the highest average wages per worker are Utilities (\$131,500), Mining, Quarrying, and Oil and Gas Extraction (\$99,886), and Real Estate and Rental and Leasing (\$81,711). Regional sectors with the best job growth (or most moderate job losses) over the last 5 years are Construction (+313 jobs), Manufacturing (+172), and Professional, Scientific, and Technical Services (+105).

Over the next 1 year, employment in Harrison County, Texas is projected to expand by 93 jobs. The fastest growing sector in the region is expected to be Management of Companies and Enterprises with a +1.3% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Health Care and Social Assistance (+19 jobs), Manufacturing (+13), and Construction (+10).

#### Occupation Snapshot

The largest major occupation group in Harrison County, Texas is Production Occupations, employing 3,494 workers. The next-largest occupation groups in the region are Office and Administrative Support Occupations (2,691 workers) and Management Occupations (2,264). High location quotients (LQs) indicate occupation groups in which a region has high concentrations of employment compared to the national average. The major groups with the largest LQs in the region are Production Occupations (LQ = 2.50), Construction and Extraction Occupations (1.71), and Educational Instruction and Library Occupations (1.49).

Occupation groups in Harrison County, Texas with the highest average wages per worker are Legal Occupations (\$109,300), Healthcare Practitioners and Technical Occupations (\$105,000), and Management Occupations (\$98,500). The unemployment rate in the region varied among the major groups from 1.1% among Legal Occupations to 7.9% among Food Preparation and Serving Related Occupations. Over the next 1 year, the fastest growing occupation group in Harrison County, Texas is expected to be Healthcare Support Occupations with a +1.5% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Transportation and Material Moving Occupations (+12 jobs) and Management Occupations (+10). Over the same period, the highest separation demand (occupation demand due to retirements and workers moving from one occupation to another) is expected in Production Occupations (360 jobs) and Food Preparation and Serving Related Occupations (307).



#### **Industry Clusters**

This cluster employs 1,895 workers in the region with an average wage of \$107,720. Employment in the Chemical cluster is projected to expand in the region about 0.3% per year over the next ten years.

Industry Clusters for Harrison County, Texas as of 2023Q4



#### Annual Average Projected Job Growth by Education Levels







The next-largest sectors in the region are Manufacturing (418 workers) and Accommodation and Food Services (324). High location quotients (LQs) indicate sectors in which a region has high concentrations of employment compared to the national average. The sectors with the largest LQs in the region are Utilities (LQ = 5.19), Agriculture, Forestry, Fishing and Hunting (3.63), and Mining, Quarrying, and Oil and Gas Extraction (3.58).

Over the next 1 year, employment in Marion County, Texas is projected to contract by 1 jobs. The largest major occupation group in Marion County, Texas is Food Preparation and Serving Related Occupations, employing 286 workers. The next-largest occupation groups in the region are Management Occupations (249 workers) and Production Occupations (249). High location quotients (LQs) indicate occupation groups in which a region has high concentrations of employment compared to the national average. The major groups with the largest LQs in the region are Healthcare Support Occupations (LQ = 1.90), Production Occupations (1.76), and Food Preparation and Serving Related Occupations (1.39). Occupation groups in Marion County, Texas with the highest average wages per worker are Legal Occupations (\$104,400), Computer and Mathematical Occupations (\$86,200), and Management Occupations (\$86,100). The unemployment rate in the region varied among the major groups from 2.1% among Healthcare Practitioners and Technical Occupations to 7.4% among Food Preparation and Serving Related Occupations.

Over the next 1 year, the fastest growing occupation group in Marion County, Texas is expected to be Healthcare Support Occupations with a +1.4% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Healthcare Support Occupations (+3 jobs) and Healthcare Practitioners and Technical Occupations (+1). Over the same period, the highest separation demand (occupation demand due to retirements and workers moving from one occupation to another) is expected in Food Preparation and Serving Related Occupations (53 jobs) and Healthcare Support Occupations (31).



## **Industry Clusters**

A cluster is a geographic concentration of interrelated industries or occupations. The industry cluster in Marion County, Texas with the highest relative concentration is Wood/Paper with a location quotient of 17.32. This cluster employs 332 workers in the region with an average wage of \$53,895. Employment in the Wood/Paper cluster is projected to contract in the region about 0.6% per year over the next ten years.

Industry Clusters for Marion County, Texas as of 2023Q4




## Annual Average Projected Job Growth by Education Levels




Employment for Panola County, Texas



# Wage Trends



# **Industry Snapshot**

The largest sector in Panola County, Texas is Construction, employing 1,385 workers. The next-largest sectors in the region are Educational Services (977 workers) and Retail Trade (937). High location quotients (LQs) indicate sectors in which a region has high concentrations of employment compared to the national average. The sectors with the largest LQs in the region are Mining, Quarrying, and Oil and Gas Extraction (LQ = 27.42), Agriculture, Forestry, Fishing and Hunting (3.69), and Construction (2.50).

Over the next 1 year, employment in Panola County, Texas is projected to expand by 3 jobs. The fastest growing sector in the region is expected to be Management of Companies and Enterprises with a +0.8% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Health Care and Social Assistance (+5 jobs), Professional, Scientific, and Technical Services (+3), and Construction (+1).

The largest major occupation group in Panola County, Texas is Construction and Extraction Occupations, employing 1,246 workers. The next-largest occupation groups in the region are Management Occupations (1,005 workers) and Office and Administrative Support Occupations (857). High location quotients (LQs) indicate occupation groups in which a region has high concentrations of employment compared to the national average. The major groups with the largest LQs in the region are Construction and Extraction Occupations (LQ = 2.96), Building and Grounds Cleaning and Maintenance Occupations (1.65), and Installation, Maintenance, and Repair Occupations (1.60).

Occupation groups in Panola County, Texas with the highest average wages per worker are Legal Occupations (\$105,200), Architecture and Engineering Occupations (\$94,600), and Computer and Mathematical Occupations (\$91,700). The unemployment rate in the region varied among the major groups from 1.8% among Life, Physical, and Social Science Occupations to 7.9% among Farming, Fishing, and Forestry Occupations.

Over the next 1 year, the fastest growing occupation group in Panola County, Texas is expected to be Healthcare Support Occupations with a +1.1% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Transportation and Material Moving Occupations (+2 jobs) and Educational Instruction and Library Occupations (+2). Over the same period, the highest separation demand (occupation demand due to retirements and workers moving from one occupation to another) is expected in Construction and Extraction Occupations (110 jobs) and Transportation and Material Moving Occupations (98).











# Annual Average Projected Job Growth by Education Levels




## Credit Enrollment by Full-time / Part-time Status Fall Semesters



## Credit Students by Ethnicity Fall Semesters Trend







## Credit Students by Gender Fall Semesters Trend














#### Semester Credit Hours by County







# Definition of Distance Learning Modes of Delivery

#### Internet Courses:

#### PC Provides for PC

Panola College students are enrolled in Internet courses offered by Panola College.

#### PC Provides for VCT/DigiTex

Students enrolled in other community colleges take Panola College Internet courses through the Virtual College of Texas (VCT). These students are not counted toward state funding, but Panola College receives a lease fee for each student.

#### PC Hosts for VCT/DigiTex

Panola College students are enrolled in other community colleges' Internet courses through the Virtual College of Texas. Panola College receives state funding for these enrollments and pays lease fees to the providing colleges.

#### PC Provides for PC

Flex classes – Students are enrolled in Internet courses for terms shorter than sixteen weeks. Two eight-week flex courses are offered in the fall and spring semesters and courses of various lengths are offered in specific programs as needed.

#### PC Provides Online Hybrid for PC

Panola College students are enrolled in classes offered by Panola College in which 51-84% of the instruction occurs online.

#### Video Conference Courses:

#### PC Provides for PC Students at Remote Sites

Panola College students are enrolled in Panola College courses offered via video conference. Remote sites may include Shelby Regional Training Center, Marshall College Center, area high schools, or sites chosen by the students.

#### Interactive Television (ITV) Courses:

#### PC Provides for PC Students at Remote Sites

Panola College students are enrolled in ITV courses offered by Panola College. Only the students at remote sites are counted in this category--students seated in the originating classroom with the instructor are not included. Remote sites include Shelby Regional Training


Center, Marshall College Center, and area high schools.

### PC Provides Hybrid/Flex for PC

Students enrolled in ITV classes in terms shorter than sixteen weeks meet face-to-face or via ITV with the instructor with 51-84% of the instruction online.

## Fall Distance Learning Enrollment Unduplicated Head Count





### Percentage Who Completed a Degree or Certificate





## Percent and Number of Full-time Faculty by Degree and Gender (Fall 2023)





### Need-Based Aid Received by Students p. 1










